#### **Director of Finance & Sponsorship Committee's Report**

- March was another month with lots of Club activity. Club Bar, Functions and the final month of Nippers for the season. Income of \$44K. Income was led by the Club Bar at \$16K (best month this year for 3rd month in a row Margaret and team doing great job, plus bar after State champs win), Function income at \$7K, Events at \$4K (Boaties Trivia) and Donations \$6K (Annual Compliance Grant previously called Fundraising Club distribution). Total Revenue of \$44K vs \$11K last year.
- Expenses above last year for Feb at \$43K vs \$29K. Main reason being variable expenses associated with the Bar, functions and nippers BBQ with the increased activity in these areas.
- Normal expenses remain well controlled but include operational costs of the club such as Wages, Depreciation, Cleaning and R&M/Rescue supplies. Carnival Entry fees were incurred for Masters and Nippers for the NSW State Champs.

<ul> <li>A reminder that last year we had received \$56K of COVID grants vs \$0 this year.</li> <li>This year, underlying income is sitting approx. \$100K more than the comparative period last year (\$10K subs, \$90K Bar and Function). As we've discussed, these income streams have variable expenses associated with them that mean our expenses have also increased in order to earn that revenue, so our underlying expenses have gone up by about \$90K.</li> <li>I'd like to thank the Board for their conservative approach to spending while income streams normalise after COVID.</li> <li>Small Profit of approx. \$850 for the month. YTD position is a profit of \$1.6K, we will still need to remain prudent with expenses. (we lost \$14K in April last year).</li> <li>Sponsorships we are still exploring options with The Newport, and will have to re-engage with Pittwater RSL in October 23.</li> <li>Reminder: according to our regulations, all board members are authorised to spend up to \$200, the Director of Finance can approve up to \$2,000 and the Board needs to approve amounts over \$2,000.</li> </ul>

Items, News or Issues to report since last meeting

DA Update –

The Sydney North Planning Panel meeting that was scheduled for the 22<sup>nd</sup> March was cancelled. Our understanding is that the new panel meeting may be 4-5 weeks from that date. This means that the hearing will be beyond the required timeframe for it to be heard and as such the council is preparing to lodge action with the Land and Environment court.

During the election campaign we gave the candidates the chance to provide answers to 2 questions related to the DA and provided those answers for our members to see.

Police Youth command program – for the past 8 weeks we have been running a program with the police youth command where they bring 8 students from the Hornsby command area to Newport for 4 hours on a Wednesday. This finished on 5<sup>th</sup> April when 6 of them completed the assessment for the Surf Survival certificate. Thank you to Peter Fenley from Bilgola for running the assessment, and to our members Keelan Smith and Stephen Middleton for helping out on the program. The increase in knowledge confidence in the surf over the program was significant as was the positive interaction with the people running the course.

- A reminder that last year we had received \$56K of COVID grants vs \$0 this year.

- Small Profit of approx. \$850 for the month. YTD position is a profit of \$1.6K, we will still need to remain prudent with expenses. (we lost \$14K in April last year).
- Frustratingly after a great year in the shop, we have had some "excess" clothing stock arrive from the State nipper program. This is expensive and initial efforts to move have resulted in negative feedback about pricing. I have spoken with those involved, but it is to be noted that purchases over \$200 are to be approved by the Director of Finance. Over \$2,000 requires Board approval.
